Thatta Kedona - The Toy Village of Pakistan, 183 mins, 2005, Pakistan

- Thatta Kedona is a remarkable village in rural Pakistan. 36 volunteers from Western countries have visited and coached the village people in a help to self help project since

1991. Dolls and tin toys reflecting regional cultures of Pakistan are products which generate cash income for the farming families through the local cooperative-like NGO. Hence the playfulness of a "toy village" is on both sides: for the villagers by manufacturing hand-craft toys for cash in a not-yet industrialized region avoiding rural exodus to the big cities (poverty slums that are generated in cities by migration). -- And on the other side one can notice the joy of Western volunteers being confronted at work by their own history framework but in present time and with a very foreign and sometimes strange context.

Ladies First, 2004, 47 mins—5 segments, Rwanda, Wide Angle

- Ten years after the bloody genocide that killed an estimated 800,000 people in just 100 days, Rwanda's women are leading their country's healing process and taking their society forward into a different future. They are playing a remarkable role in politics and are also emerging as prominent figures in the business sector. Profiling women on the forefront of change, Emmy-winning "Ladies First" reveals the challenges facing them and their country as Rwanda struggles to build a sustainable peace between the majority Hutus and minority Tutsis -- a peace that has eluded the country for almost half a century.

### Practitioner Profiles

African System of Human and Peoples' Rights, 30 mins, Queen's University of Belfast

- Dr. Ibrahim Ali Badawi El-Sheikh, former Chair of the African Commission on Human and Peoples' Rights discusses the evolution of the Commission and the role which Non-Governmental Organizations have played in the this process. Dr. Badawi considers the role of the Commission, its complains procedure, and the lack of funding which affects its ability to carry out its mandate. Dr. Badawi then speaks about the role of Chair of the Commission as well as explaining what transpires during a session of the Commission, and finally what has stood out in his mind during his tenure with the African Commission.

Professor Weissbrodt also considers the role of the Sub-Commission on the Promotion and Protection of Human Rights and explains what transpires during its annual meetings, including discussion of the 1503 and 1235 Procedures. Finally, Professor Weissbrodt introduces the University of Minnesota Human Rights Library which holds the largest selection of instruments and materials related in international human rights law on the internet.

Judge Higgins then speaks about procedural issues, the judges and their background, the daily functioning of the Court, and finally the value of a judgement rendered by the Court .

Noble Peace Prize Laureate Joseph Rotblat, 10 mins, Queen's University of Belfast

- Noble Peace Prize Laureate Joseph Rotblat introduces himself, the Pugwash Conference and discusses the winning of the Noble Prize. Professor Rotblat then considers international security in the pre- and post- nuclear age, during the Cold War, and after. Professor Rotblat considers the role of international law as it relates to nuclear weapons and the relevance of the Advisory Opinion of the International Court of Justice on the *Use or Threat of Use of Nuclear Weapons*.

- Phillippe Kirsch, President of the International Criminal Court, sat down for an interview in September 2005 in which he introduced himself, and went on to give the historical background of the creation of the International Criminal Court. President Kirsch then went on to explain how the Court functions, its structure, and finally gave a status report of the Court's activities as of 2005.

Judge Pillay speaks about the legacy which the ICTR will leave in respect to the evolution of international jurisprudence, and discusses the means by which the ICTR will finish its work.

Treaty-Based System – CERD, 57 mins, Queen's University of Belfast

- Professor Linos-Alexander Sicilianos of the University of Athens and Vice-Chair (2004-2006) of the Committee on the Elimination of Racial Discrimination (CERD) considers the functioning of the Treaty-based system, the commonalities amongst the Treaty Bodies, the powers of these committees including General Comments and Individual Communications, and the role which NGOs and National Human Rights Institutions play within the system. Professor Sicilianos then turns to consider issues related to the CERD Convention, including the obligations of the State and the rights of individuals; and the Committee: how often and where it meets, and issues of harmonisation and follow-up procedures. Finally, Professor Sicilianos considers proposals to reforming the Treaty-based system put forward in 2006.

Democracy in the Rough, 2006, 44min—Four 11 min segments, Congo, Wide Angle

- WIDE ANGLE is on the ground as the Democratic Republic of Congo holds its first elections in 45 years -- an election supported by more than \$450 million from the United Nations. The stakes are high in Congo, a nation rich in timber, diamonds, and coltan -- a substance essential for small electronics from cell phones to laptops to Play Stations -- but the country is reeling from decades of dictatorship and a civil war that left more than four million dead.
